### **Federation of European Publishers' VAT Resolution**

On 1 December 2016, the European Commission issued a long-awaited and much-needed proposal to allow Member States – if they so wish – to apply the same reduced, super-reduced and zero rates they apply to print books also to books on all kinds of supports. The book industry in Europe welcomed this initiative wholeheartedly as a decisive step towards the end of the unjustified discrimination in the fiscal treatment of books in different formats.

Nonetheless, one year later, we regret to note that not only has this proposal not been adopted yet, but it is not even on the agenda of the ECOFIN Council or its related preparatory bodies, despite it being a positive, forward-looking measure, aimed at encouraging reading and boosting e-commerce, flexible, and in addition voluntary.

With this Declaration, therefore, the Federation of European Publishers and its 29 members – national associations of publishers of books, learning materials, and/or journals in a range of media from all over Europe – gathered in their General Assembly, would like to express their disappointment at this unwarranted delay and strongly encourage all parties involved to work towards a swift conclusion of the process and a positive outcome for the European book sector, culture and citizens.
